### EC9C0 Topics in Development Economics (2024-2025) Stefano Caria

### **Key Module Information**

This module introduces you to several central topics in development economics.

I will teach the first half of the module, covering the first five weeks of the term. We will explore six foundational topics: poverty, firms, workers, climate change, gender and social policy. These topics are conceptually central to development economics, since they provide key microeconomic building blocks to understand aggregate economic and political outcomes. They are also highly policy relevant: "how can we raise employment?", "how can we reduce poverty?" and "how we can protect our citizens against climate change?" are some of the most common questions for which policy makers seek researchers' help. For each topic, we will cover basic stylized facts, understand core theories and their implications, and discuss the latest empirical evidence.

In the second part of the module, Sharun Mukand will cover another set of topics looking at the cultural and political foundations of development.
